Lion Hills Center Pool Rules

The following are rules for Lion Hills Pool Members.
These rules must be followed in order for pool membership to continue.

No swimming is allowed by anyone unless Lion Hills Certified Lifeguards are on duty!

1. Obey the lifeguards.
2. All swimmers must sign in and out with Manager or Cabana Staff.
3. Swimsuits only; no cut off jeans allowed. Family appropriate swimwear is required.
4. No running in the pool area.
5. No diving. Ever.
6. All food, soft drinks, sport drinks, and alcoholic beverages are to be purchased at Lion Hills. No outside coolers, beverages, or food of any type may be brought into the facility. No glass or ceramic items allowed in the pool area. All beverages must be in plastic or aluminum containers.
7. No fighting, horseplay or excessive noise permitted in the pool area.
8. Smoking is permitted in designated areas only.
9. Any member or guest that appears to have become intoxicated will be refused additional alcohol .
10. Chewing gum is not permitted while swimming.
11. Only lifeguards are allowed on lifeguard stands.
12. No loitering or talking to lifeguards on duty.
13. Children under 12 years old are not allowed in the pool area unless accompanied and supervised by someone who is at least 16 years of age. Children who cannot swim must be accompanied by an adult at all times.
14. Diapers are not permitted in the pool. Please use approved swim diapers.
16. Parents are responsible for the actions of their children under the age of 18.
17. Non-service animals are not allowed on the premises.
18. Anyone with open blisters, cuts, sores, etc. is not allowed to use the pool.
19. Spitting, spouting water, blowing the nose or discharge of any bodily waste in the pool is strictly prohibited.
20. The first violation of pool rules or lifeguard instructions will result in a warning. A second violation will result in removal from the pool area. A third violation will result in suspension from the pool.
21. The Lifeguards on duty has final safety authority in all situations and will close the pool for 30 minutes after the last clap of thunder or lightning. Members and guest must move under the cabana or inside the clubhouse to wait out the delay.
22. If any questions arise, obey the lifeguard.

Guests: A member may bring no more than two (2) guests to the pool at any time during regular pool hours. The cost for each guest is \$10 per visit. The member is responsible for the cost of each guest if the guest does not pay. The member is responsible for the cost of any food purchased by their guest if the guest does not pay. Lastly, the member is responsible for seeing that their guest follows all pool rules.
